#### To nominate, you must:

- Complete this nomination form and sign the declaration
  - Provide a recent photograph of your head and shoulders
  - Provide a criminal history report (such as a police check) that is less than 6 months old

OR

Apply for a police check and supply the required identity documents

If you do not have a police check that is less than 6 months old, then you can complete the Nationally Coordinated Criminal History Check form and supply it to ECSA along with your required identity documents.

There is no cost to apply for a police check as part of your nomination.








Police check application and ID
